• Roads/Utilities Update-Chiglo: Miner reported

• Chiglo has graded all the CRV roads and tried to use the reclaimer to reach further down into the ditches was unable to go much deeper into the ditches than he had done already

• Maintenance Shed Update: Miner reported

- The cold storage side of the shed has been cleaned out
- The fuel barrel needs to be moved outside
- Ebner reported the water line was bored to the shed and the water will be hooked up when STS Plumbing installs the holding tanks. STS Plumbing is waiting on state permits to install the tanks

• Water Meter Installation Update: Miner reported

- o 78 meters have been installed with only a few needing the line side valve replaced
- There have been a few places that did not have a ground wire, CRV will be sending letters to them suggesting they get a ground wire installed

- Everything appears to be going well. There have been a only few issues with scheduling
- At every installation documentation is collected which includes the new meter number, old meter number and final meter reading, type of water line that comes into the residence and if a sump pump is being used and if so where is the water being discharged. A picture is taken of each new meter and water line coming into the residence
- The water line into the residence information will be used to complete the Lead and Copper Rule spreadsheet
- Graham and Miner have a phone call with CentralSquare on Thursday to start getting meter information entered into the billing system and to learn how to run a monthly billing using the meter reading of the actual water used per account

OTHER:

• Fillmore County Assessor-Reassessment of CRV properties:

- CRV office and Council received notice from the Fillmore County Assessor's Office they will be starting to reassess all CRV properties starting in May. The process will take a few months
- This is done approximately every 5 years
- There will not be appointments set up, they will arrive at a property, knock on the door to let the resident know who they are and why they are there
- They will ask to look inside the house, take measurements of all buildings and pictures of the outside of the buildings, they will not enter any out buildings. If a resident is not home they will leave a notice on the door asking the resident to call them to set up a time to come back to look inside the home
