CITIZENS/OTHERS PRESENT /WISHING TO BE HEARD: Jeff Holmquist-Harter's Quick Clean-Up, Kirsten Zoellner-Fillmore County Journal, George Graham

•Jeff Holmquist-Harter's Quick Clean-Up

- o Holmquist stated in his opinion it would be better for CRV to extend their contract with Harter's instead of rebidding. Holmquist stated in the past his experience has been rebidding seemed to increase the contract price more than if the contract had been extended
- o CRV is considering not owning the trash carts any longer. The cost to replace a broken trash cart is about \$110.00 per cart, with automated pick up more are in need of repairs/replacement
- Holmquist stated most cities do not own the trash carts
- o Fuel surcharges will fluctuate with the cost of fuel
- o Holmquist will put together options for the Council to review which will include length of agreement options

Permit Status/Projects in Process/Inquiries/Updates:

- Pettit reported he received questions regarding the buildable area on property near Oak View Loop that is for sale.
 - Pettit contacted Fillmore County regarding bluffland protection for that property.
 - o To build anywhere else on the property would be very expensive because it is protected bluff land
 - o It was determined the only buildable area is where the old building site was which is not in the Oak View Loop subdivision.
 - o The property has 2 wells, one of which has been tested and is good
 - o They will locate 2 sites for the septic system and contact Fillmore County

ROADS/WATER/SEWER:

- 2022 Freightliner Delivered May 24, 2022: The Freightliner was on display for the Council
- Water Tower Road Easement:
 - The easement is for CRV utility maitenance for the water pump and water tower only
 - O'Koren stated it is clear from the language in the easement the easement is on private property and is not a public access.
 - CRV will place a sign at the bottom and top stating it is not a public access. The property owners can post their property also

- The easement starts where the CRV park property ends
- Information will also be included in the 3rd quarter newsletter

County Line & Deep River Roads/2023 chip sealing-Derek Olinger:

- Olinger will meet with Chiglo to discuss possible repair options for County Line and Deep River roads.
- Because of the estimated cost of \$105,000.00-\$118,000.00, it is not possible to chip seal all the roads next year that will be crack sealed this year.
- Knutson suggested the roads with the most cracks should be chip sealed. Olinger and Chiglo will determine which
 roads should be chip sealed.
- This will be part of the 2023 budget discussion

• Lift Station Railing:

o Council had questions and Chiglo was not present to answer them. Moved to June 21st meeting.

• Storm Drain/Lift Station F450 Winch:

Council had questions and Chiglo was not present to answer them. Moved to June 21st meeting.

OTHER:

• Featherstone Farms 60% Principle MIF loan Reimbursement \$2,529.51-Final:

- o Featherstone Farms fulfilled their monthly MIF loan payment obligation and returned the Jobs Report
- o March 2021, Featherstone Farms paid the MIF loan in full
- They are entitled to 60% reimbursement of the total principle paid \$4,215.85 (\$3,368.46 principle paid in 2021 / \$847.39 principle paid in 2022) in the amount of \$2,529.51
