- **2020 Fillmore County Bridge Reports:**

- Main concern is the approach on the east side of the Ridgeview bridge has settled a little and is sticking up, a plow could potentially catch it. This will need to be fixed
- Debris against the Ridgeview Bridge supports could cause issues with undermining the supports. Debris should be removed.
- Ridgeview bridge will be looked at during the May 4th road tour
