## Bonnie Norstad 37.5kW Ground Mount Solar Array Public Hearing

The June 15, 2021 Bonnie Norstad 37.5kW Ground Mount Solar Array Public Hearing was called to order by Mayor Dennis Overland at 6:54 p.m. in the Rushford Village Community Center (COVID-19 Concerns) Council Members present: Mike Ebner, Roger Knutson, Robert Hart and Rick Ruberg; Planning/Zoning Administrator Jon Pettit, City Attorney Joseph O'Koren, Treasurer Judy Graham and Clerk Mary Miner.

- Mayor Overland clarified the hearing was published as a hearing for James Norstad to construct 37.5 kW Ground Mount Solar Array on parcel R05.0106.030 but the hearing is for Bonnie Norstad to construct 37.5 kW Ground Mount Solar Array on parcel R05.0106.030. After the public hearing notice was published CRV was informed MiEnergy will not allow the same person to construct a solar array within 1 mile of another solar array they own. MiEnergy does allow spouses to construct a solar array within 1 mile of each other, therefore the name on the permit application was changed from James Norstad to Bonnie Norstad. All the solar array information received from Paul Kreidermacher of MinnSolar remains the same

- Pettit reported the Planning and Zoning Commission sends the solar permit application forward to the CRV Council with a favorable recommendaton

- Pettit reported he received two separate parcel split permit applications from Mathy Construction. Mathy wants to sell some property
  - The application for the Deep River Road area was not necessary as they will not be splitting any parcel but will be cleaning up the legal discription and a quick claim deed will be executed, Mathy will record everything with Fillmore County

- The application for the area along the Root River and State Highway 16 is asking for multiple parcels to be split and is difficult to understand. Mathy will have their engineer draw up the parcels as they would like them to be split as well as determine the floodway and flood fringe. Mathy will present this information at the July 20, 2021 Planning and Zoning Meeting.
- Pettit reported the Planning and Zoning Board is not willing to make a motion one way or the other to bring anything forward to the Council regarding the Vern Bunke, Foothill Development.

### \*Dust Control-CRV Resident on County Rd:

- A CRV resident requested reimbursement for dust control on Tower Ridge on a portion of the Fillmore County section of the road.
