## • Jack Hedin Campsites Update:

- Pettit contacted Cristal Adkins, Fillmore County Zoning Administrator, to verify the CRV Campground definition is the same as Fillmore County, it is
- According to CRV Campground definition, anyone can charge for one campsite and be ok, if they charge for two or more campsites they are then considered a campground and would have to follow the CRV Campground Ordinance
- What Hedin is proposing in the letter and map he provided is not in accordance with the amended CRV Campground definition
- Hedin could have one campsite on the Anderson property and one campsite on the Peterson property that he charged for and would be ok.
- The main reason Fillmore County gave for amending the campground definition was the need to keep an eye on what was being done as it relates to sanitary sewer systems
- o Pettit will contact Hedin

#### **OTHER ISSUES/CONCERNS:**

#### • Rushford Airport Building Construction:

- A while back Pettit received a call for someone associated with the hangar project asking if a zoning permit would be required, Pettit told them it would be but has not heard from them since
- Pettit reported he saw are article in the Fillmore County Journal that Rushford was planning to build an airplane hangar at the Rushford Airport
- The Rushford Airport is a federally funded airport, any plans may need to be reviewed by CRV Engineers Bolton & Menk
- Planning and Zoning Board wanted to be proactive and directed Miner to send Rushford a letter reminding them a zoning permit is required, the zoning permit application would be included with the letter

## • Rebecca Charles-CEDA Updates/Reports:

• Charles was not present but did provide her monthly report for review

• Charles continues to work on the CRV Comp Plan

#### Paul Ulrich Property:

- Pettit reported he received an inquiry from Paul Ulrich to split his 10 acre parcel into two parcels, this would provide a buildable lot
- o This property has already been split, another split would make it a 2 parcel subdivision, both driveways would come out onto a hard surface road

**Recorder:** Mary Miner

- o Ulrich would have to follow the subdivision ordinance which would include the need for a public hearing
- Miner sent the zoning permit application and subdivision ordinance to Ulrich
- Corey Geyer Property: Nothing new to report, Pettit has not received any permit applications
