ROADS/WATER/SEWER:

- Roads/Utilities Update-Chiglo:
 - o Roads are not frozen yet
- F450 Repairs/Tires:
 - o Repairs needed include mirror brackets have rusted through and need to be replaced, the seatbelt retractor on the drivers side does not retrack and needs to be replaced, 6 tires need to be replaced
 - O Chiglo priced tires and chose tires that are about the middle of the price ranges. Total cost to do the proposed repairs and replace 6 tires is \$2,148.00

Motion made to replace F450 mirror brackets, seatbelt retractor and 6 tires at a of cost of \$2,148.00

Motion by Hart, 2nd by Link, Carried.

• Sellable CRV Items:

- o Ebner would like Chiglo to put together a list of items that could be sold for the Council to look at
- o Items could include the small V-Plow, snowblower, old tire chains and other small miscellaneous items

• Maintenance Shed:

- o Finishing bathroom. Metal is being installed for the walls and ceiling. STS Plumbing and Heating will have to install the toilet and sink before the final plumbing inspection can be done.
- o All electrical and plumbing will be surface mounted
- \$20,000.00 is in the 2024 budget to install insullation and metal on the walls and ceiling of the north side of the maintenance shed. So far the 2023 part of the project is coming in a little under budget.
- The gas barrel lean has been completed

OTHER:

• 2024 CEDA Contract:

- o Proposed 2024 CEDA contract is not to exceed \$15,202.00 annually. This is based on an average of 8 hours every other week. 2023 contract was \$14,479.00
- o In 2023 Rebecca Charles worked with UW La Crosse on the Trail Study, looked into a potential use for the Pioneer Seed building on State Highway 43 South, submitted various grant applications
- CRV received a \$5,000.00 Rural Feasibility Study Grant from Compeer Financial to help cover the costs of the Comp Plan. Charles continues to work on CRV Comp Plan which is very time consuming and requires a lot of investigation
- Charles will not have the Comp Plan completed by the end of this year. She will need time to compile the
 information from the surveys and community public input meeting, she estimates it should be completed in March
 2024
- Hart questioned what benefits CRV has gotten from the Comp Plan. Overland and Graham stated the Comp Plan is needed for various reasons. It is suggested Comp Plans be updated every 10 years. The cost of the 2013 Comp Plan was approximately \$20,000.00
- Ebner stated he feels there is enough going on right now to renew the CEDA contract for 2024. Graham stated it only takes one project to make the CEDA contract worth while. Hart asked for an example of a project, Graham stated the Comp Plan and the Trail Study could effect CRV citizens. Overland stated calls are made to Charles throughout the year about various inquires.
- In that past CEDA was hired for specific projects only but it was determined to be more cost effective to have a
 yearly contract instead
- O Concerns: Ruberg's concern, is CRV getting it's money worth. This year CRV spent \$14,000.00 and only received a \$5,000.00 grant which does not make it profitable. Overland stated it is not meant to be profitable, Ruberg stated it is costing someone and the Council is responsible for CRV residents. Ruberg stated CRV has MIF money that can only be used for a development and CRV is not in the position to buy ground to develop something. MIF funds can be used to help a business create and maintain jobs but the funds cannot be used to purchase the land for that business. If a project was proposed DEED would be contacted to determine if MIF funds could be used. Hart stated CRV is unique because it is so rural but maybe there could be potential projects the MIF funds could be used for if all the MIF loan criteria was followed. Rebecca would like to know about projects to help get them going and to see what incentives CRV might be able to offer
