- Machutt on Tower Ridge is putting up the shed he was permitted for
- Les Ladewig was unable to attend this meeting but plans to attend the November meeting regarding the Ladewig Subdivision
- Received a call from Jesse McNamer about placing another residence on the same parcel a current residence is located. Pettit stated he could not see how this could be done unless the parcel was split off for the second dwelling but wanted to wait until McNamer was present to discuss it further
- Overland questioned if CRV has an ordinance/policy that pertains to VRBO's (Vacation Rental By Owner). CRV does not
  - o Pettit was not sure why CRV would want something regarding this as we do not regulate who rents a place
  - Overland stated there might be revenue for CRV if there was a license or tax that could be collected
  - o The VRBO would be the only dwelling allowed on a parcel
  - o CRV doesn't regulate B&B's currently. This is where the resident allows someone to rent a room in their home
  - Will check with Fillmore County to see what they have regarding VRBO regulations
