- o Report mentioned placing 3 barrier posts at the well. It is not understood why this would be needed because of where the well is located. This was not mentioned to Chiglo during the inspection
- o Chiglo repaired the window screen at the pump house

 - o O'Koren stated this agreement is required by the State for prosecution duties and needs to be renewed
 - The total cost is \$780.00 which is divided between four cities
