Fee Schedule Ordinance

Ordinance No. 22

Approved July 21, 2026, Summary Published August 17, 2026, Effective August 17, 2026

WHEREAS, all fees payable to the City, shall be governed by this Ordinance; except that if any Ordinance or State law provides for or requires the payment of a fee to the City and this Ordinance makes no reference thereto, then such other Ordinance or law shall govern; and

WHEREAS, all fees shall be due and payable in full at the time specified in the Ordinance or State law, and if no such time is provided, fees shall be due and payable upon demand of the City Council or other authorized City Officer.

NOW THEREFORE, the City Council of the City of Rushford Village, Minnesota, ordains fees for Services are listed below and shall be as follows:

<i>Fee Deposit Required: A minimum deposit may be required at the time of application to cover the projected City of Rushford Village costs for Project Planning, Engineering and/or other Professional Fees as required for a project. Payments for the balance of fees over the deposit may be staged as the project progresses. Additional deposits must be made prior to additional costs being incurred. The balance of a deposit that is unused at the completion of a project will be returned to the depositor. A Performance bond may be required to protect the public interest and/or to protect or restore public infrastructure.</i>

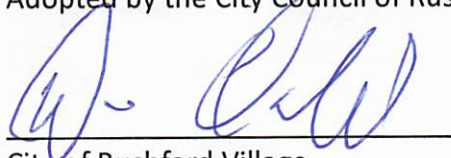
